Data Protection Supplier Privacy Notice



At Pyropress Limited, we are committed to protecting and respecting your privacy.

We will never share any of your personal information with anybody outside of Pioneer Safety Group for mailing or marketing purposes unless we have your consent to do so.

4. How long do we keep your personal information?

We may store the personal information that you have provided in our databases. We will only keep your personal information for as long as reasonably necessary taking into consideration our need to answer queries or resolve problems and comply with legal requirements under applicable law(s). This means that we may retain your personal information for a reasonable period after we stop using your products or services. After this period, your personal information will be deleted from all systems.
